November 21st, 1917.

Minutes of the THIRD and ADJOURNED SIXTH REGULAR MONTHLY MEETING of the STATE HIGHWAY DEPARTMENT. The following members were present:

The meeting was called to order by the Chairman and the following business was transacted:

Motion by Mr. Odle, seconded by Mr. McLean that the Engineer be instructed to send out form letters with reference to the status of the engineering as per letter suggested by him. (See files.) Motion carried.

Motion by Mr. McLean, seconded by Mr. Odle that FEDERAL AID be granted VAL VERDE COUNTY not to exceed \$10,000 on HIGHWAY NUMBER FOUR between Del Rio and DEVIL'S RIVER. Motion carried.

Motion by Mr. Odle, seconded by Mr. McLean that the consideration of re-locating the route through GONZALES instead of HARWOOD and Luling from WAELDER via GONZALES, intersecting the original route at Seguin be considered. Motion carried.

Motion by Mr. Odle, seconded by Mr. McLean that route be changed as above suggested, via Gonzales.

Motion by Mr. McLean, seconded by Mr. Odle that a STATE HIGHWAY be designated as follows: Beginning at CISCO via DeLeon, Dublin, Hico, Iredell, Meridian and connecting with NUMBER TWO to Waco. Motion carried.

Motion by Mr. McLean, seconded by Mr. Odle that an intercounty highway be designated beginning at Evant through HAMILTON COUNTY to Hico. Motion carried.

Motion by Mr. Odle, seconded by Mr. McLean that HIGHWAY NUMBER THREE be re-designated from Schirtz in GUADALUPE COUNTY via Selma, intersecting the POST ROAD and following same into San Antonio. Motion carried.

Motion by Mr. Odle, seconded by Mr. McLean that an intercounty highway be designated from TAYLOR via Thorndale, Rockdale, Cameron, Maysfield, Port Sullivan to Hearne. Motion carried.

Motion by Mr. McLean, seconded by Mr. Odle that STATE AID be granted WAYETTE COUNTY not to exceed \$14,134 on HIGHWAY NUMBER THREE. Motion carried.

Motion by Mr. Odle, seconded by Mr. McLean that STATE AID be granted WAYETTE COUNTY not to exceed \$14,134 on HIGHWAY NUMBER THREE. Motion carried.

Motion by Mr. Odle, seconded by Mr. McLean that FEDERAL AID be granted GONZALES COUNTY not to exceed \$48,000 on HIGHWAY NUMBER THREE between Waelder and GUADALUPE COUNTY line. Motion carried.

Motion by Mr. McLean, seconded by Mr. Odle that FEDERAL AID be granted GUADALUPE COUNTY not to exceed \$34,900 on HIGHWAY NUMBER THREE. Motion carried.

Motion by Mr. Odle, seconded by Mr. McLean that State Aid be granted Sandoval county not to exceed \$10,785.00 on Highway No. 3, and not to exceed ten miles and on which no Federal Aid has been granted.

Motion by Mr. Odle, seconded by Mr. McLean that Federal and State Aid be granted Childress county not to exceed \$35,000 on Highways No. 4 and 5, between county line and county line, when proper petition is presented. Motion carried.

Motion by Mr. Odle, seconded by Mr. McLean that Federal Aid be granted Fort Bend county not to exceed \$50,000 on Highway Number Three. Motion carried.

Motion by Mr. Odle, seconded by Mr. McLean that Federal Aid be granted Wise county not to exceed \$80,000 on Highway No. 2 between county line and county line. Motion carried.

Motion by Mr. Odle, seconded by Mr. McLean that Federal aid be granted Fayette county not to exceed \$36,773 on Highway No. 3, between Colorado county line and Gonzales county line. Motion carried.

Motion by Mr. Odle, seconded by Mr. McLean that State Aid be granted Fort Bend county not to exceed \$12,500 on Highway No. 3. Motion carried.

Motion by Mr. McLean, seconded by Mr. Odle that Federal Aid be granted Wharton county not to exceed \$11,763.35 on Highway Number 3. Motion carried.


Motion by Mr. Odle, seconded by Mr. McLean that Federal Aid be granted Colorado county not to exceed \$44,000 on Highway No. 3. Motion carried.

Motion by Mr. Odle, seconded by Mr. McLean that State Aid be granted Wharton county not to exceed \$15,838 on Highway No. 3. Motion carried.

Motion by Mr. Odle, seconded by Mr. McLean that State Aid be granted Colorado county not to exceed \$11,000 on Highway Number 3. Motion carried.

Motion by Mr. Odle, seconded by Mr. McLean that an intercounty highway be designated beginning at Bremond, thence to Frankling, thence to Bryan. Motion carried.

There being no further business to come before the Commission, adjournment was taken until Thursday morning, November 22nd, 1917.
