

November 26, 1918.

The Second and Adjourned Eighteenth Monthly Session of the State Highway Commission was held in the State Office Building on November 26th, with the following members present:

Curtis Hancock, Chairman,  
C. S. Fowler, Commissioner of Registration,  
R. M. Hubbard, Commissioner of Construction,  
George A. Duren, State Highway Engineer.

The following business was transacted:

Motion by Mr. Fowler, seconded by Mr. Hubbard, that the application of CHEROKEE County heretofore granted for Federal Aid in the sum of \$30,000 on Highway Number Twenty-Two from county line to county line, be rescinded. Motion carried.

Motion by Mr. Hubbard, seconded by Mr. Fowler, that the application of CHEROKEE County for State Aid on Highway Number Twenty-two, beginning at the court house in the town of Rusk, thence west to a point where the Jim Hogg Highway Number Thirty-seven intersects said Highway Number Twenty-two, to the extent of one fourth of the contract, not to exceed \$2,500, be granted. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Hubbard, that the application of SAN AUGUSTINE County for State Aid on Highway Number Eight be granted, beginning at a point eleven miles south of San Augustine, thence to the Sabine County line, not to exceed the sum of \$21,253.68. Motion carried.

Motion by Mr. Hubbard, seconded by Mr. Fowler, that the application of SAN AUGUSTINE County for Federal Aid heretofore granted on February 18th, 1918, in the sum of \$27,594.82 be and the same is hereby abandoned, State Aid having been granted in lieu thereof, increasing \$8011.50 to \$10,340 on Highway No. 8 from Shelby Co. line to 11 miles south of San Aug. Carried.

Motion by Mr. Fowler, seconded by Mr. Hubbard, that the application of FALLS County for State Aid on Highway Number Two on the Laredo Division, from county line to county line, be granted not to exceed \$4,105.20. Motion carried.

Motion by Mr. Hubbard, seconded by Mr. Fowler, that the application of McLENNAN County for Federal Aid on Highway Number Two, beginning at the city limits of Waco, thence to the bridge crossing Bosque River, be granted not to exceed \$5,000. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Hubbard, that the application of McLENNAN County for State Aid on Highway Number Seven, beginning at the corporate limits of Waco, thence extending west 4.17 miles, be granted not to exceed \$1,736.44. Motion carried.

Motion by Mr. Hubbard, seconded by Mr. Fowler, that the application of WISE County for State Aid on Highway Number Two from county line to county line, be granted not to exceed the sum of \$25,000 out of State Aid. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Hubbard, that the application of ERATH County for Federal Aid on Highway Number Ten, beginning at a point eight miles north east of Dublin at a point on the east line of District Number One, thence south west to the east corporate limits of the town of Dublin, and beginning again at the west corporate limits of the town of Dublin, thence to the east county line of Comanche County; and also beginning at a point south on Highway Number Eighteen south of Dublin on the district line Number One, thence north to the corporate limits of the town of Dublin; and beginning again at the north limits of the town of Dublin and extending north west to the west boundary line of district number one, being the east boundary line of Comanche County, be granted out of Federal Aid not to exceed the sum of \$62,000. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Hubbard, that the application of CAMERON County for State Aid on Highway Number Twelve, beginning at the corporate limits of Brownsville, thence west to the Hidalgo County line, to the extent of one fourth of the contract, not to exceed the sum of \$83,333.33, be granted. Motion carried.

Motion by Mr. Hubbard, seconded by Mr. Fowler, that the application of CAMERON County for Federal Aid on Highway Number Twelve be granted, beginning at the west corporate limits of Brownsville, thence west to a point about five miles, the end of the post road, and beginning again at a point three miles south of San Benito, thence to the corporate limits of San Benito; and beginning again at the north corporate limits of San Benito, thence north about 2½ miles to the end of the post road, not to exceed the sum of \$30,000 Federal Aid. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Hubbard, that the application of EASTLAND County for State Aid on Highway Number Eighteen, beginning at the north district line number one, thence north west to the Shackelford County line, not to exceed the sum of \$10,000, and not to exceed one fourth of the contract, be granted. Motion carried.

Motion by Mr. Hubbard, seconded by Mr. Fowler, that the application of TRAVIS County for State Aid on Number Twenty Nine, beginning at the county line of Caldwell County, thence along Highway Number Twenty Nine to where it intersects Meridian Highway Number Two, not to exceed the sum of \$25, 109.00, be granted. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Hubbard, that the application of TRAVIS County for Federal Aid on Highway Number Twenty Nine, beginning at the Caldwell County line, thence north to a point 48,400 feet, and again beginning at a point 8,554 feet from this point, thence 4,400 feet be granted out of Federal Aid in the amount of \$16,426.50, and not to exceed fifty per cent. Motion carried.

Motion by Mr. Hubbard, seconded by Mr. Fowler, that the application of FISHER County for Federal Aid on Highway Number Four, beginning at Rotan, thence north to the Stonewall County line, be granted not to exceed \$32,034. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Hubbard, that the application of FISHER County for State Aid on Highway Number Four, beginning at North Roby, thence to Rotan, be granted not to exceed the sum of \$16,800. Motion carried.

Motion by Mr. Hubbard, seconded by Mr. Fowler, that five hundred copies of the Commissioners' Biennial Report to the Legislature be published. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Hubbard, that the following salary adjustment be made:


W. W. Carson, Supt. State and Federal Aid Projects, to begin  
December first \$150.00.

Motion carried.
