

January 17th, 1921.

Minutes of the Forty-Fourth and First Adjourned Regular Monthly Meeting of the State Highway Commission, held in the State Office Building, with the following members present:

R. M. Hubbard, Chairman,  
C. N. Avery, Commissioner of Construction,  
C. S. Fowler, Commissioner of Registration,  
Rollen J. Windrow, State Highway Engineer.

The following business was transacted:

Motion by Mr. Fowler, seconded by Mr. Avery that the following intercounty highway be designated as a State Highway to be known as No. 33-B: Beginning at Clarendon in Donley county; thence to Jericho; thence to Pampa; crossing the Canadian River at the mouth of White-deer Creek; thence to Adobe Walls; thence to Spearman in Hansford county; connecting with the State Highway at Guyman, Oklahoma. Motion carried.

Motion by Mr. Avery, seconded by Mr. Fowler that the following intercounty highway be designated as a State Highway, to be known as No. 33-A: Beginning at Pampa, thence to Miami, thence to Canadian, thence to the State line. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Avery that the designation of No. 44-A, beginning at Taylor, thence to Thrall, thence to Thorndale, thence to Rockdale, thence to Milano, be canceled; and that No. 43 be further designated beginning at Taylor; thence to Thrall; thence to Thorndale; thence to Rockdale; thence to Milano; thence to Hearn; thence to Franklin; thence to Jewett; thence to Buffalo; thence to Palestine; thence to Jacksonville; thence to Troup; practically paralleling the I&GN Railroad and connecting with No. 43-A at Troup. Motion carried.

Motion by Mr. Avery, seconded by Mr. Fowler that Atascosa county be granted \$1,875.00 State aid on State Highway No. 9, for aiding in the construction of overhead crossing on the SAU&G Railroad at Station 115 plus 85 of Federal aid project No. 166; and \$8,812.23 State aid for aiding in claying subgrade on certain portions of Federal aid project No. 166, making a total of \$18,498.65 State aid on this project. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Avery that Wood county be granted \$6,500 Federal aid on State Highway No. 15 through Mineola, to be applied on a 24 foot roadway. Motion carried.

Motion by Mr. Avery, seconded by Mr. Fowler that the conditions imposed on the \$100,000 State aid granted Nueces county July 17, 1920 on the causeway be removed and that this aid be made available immediately. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Avery that the conditions imposed on the \$150,000 Federal aid granted Rusk county be removed. Motion carried.

Motion by Mr. Avery, seconded by Mr. Fowler that \$14,724.01 of the \$150,000 Federal aid previously granted Rusk county be canceled. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Avery that the \$50,000 State aid previously granted Rusk county be applied to the ends adjoining the three sections of Federal aid project No. 203 as follows: Section A, beginning at a point eight miles southwest of Henderson and extending south to the Cherokee county line. Section B, beginning at a point eight miles northwest of Henderson and extending north to the Gregg county line. Section C, beginning at a point eight miles southeast of Henderson and extending southeast to the Nacogdoches county line. Motion carried.

Motion by Mr. Avery, seconded by Mr. Fowler that \$12,000 State aid be granted Fannin county on State aid project No. 63, Highway No. 5. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Avery that the \$40,000 Federal aid previously granted Somervell county be canceled. Motion carried.

Motion by Mr. Avery, seconded by Mr. Fowler that Somervell county be granted \$18,750 State aid on State Highway No. 25, to apply beginning at a point northeast of Glen Rose at the intersection of No. 10-A, thence southwest through Glen Rose to the Bosque county line, a distance of 9.09 miles. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Avery that Somervell county be granted \$18,750 Federal aid on State Highway No. 25, to apply beginning at a point northeast of Glen Rose at the intersection of No. 10-A, thence southwest through Glen Rose to the Bosque county line, a distance of 9.09 miles. Motion carried.

Motion by Mr. Avery, seconded by Mr. Fowler that Cass county be granted \$12,409.15 additional State aid on State Highway No. 1-C, from Atlanta to the Louisiana line, making a total of \$36,351.13. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Avery that Reeves county be granted \$136,084.46 Federal aid on State Highway No. 1 from the Jeff Davis county line to the line of Road District No. 2. Motion carried.

Motion by Mr. Avery, seconded by Mr. Fowler that Reeves county be granted \$68,042.23 State aid on State Highway No. 1 from the Jeff Davis county line to the line of Road District No. 2. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Avery that Wood county be granted \$5,000 State aid on State Highway No. 42, West of Quitman, on surfacing only. Motion carried.

Motion by Mr. Avery, seconded by Mr. Fowler that Erath county be granted \$40,000 State aid on State Highway No. 10, Federal aid project No. 164. Motion carried.

Motion by Mr. Avery, seconded by Mr. Fowler that Gillespie county be granted \$9,500 State aid on Federal aid project No. 46, Highway No. 2, to apply on a two mile section through Fredericksburg. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Avery that Jefferson county be granted \$10,000 State aid on Federal aid project No. 53, Highway No. 8. Motion carried.

Motion by Mr. Avery, seconded by Mr. Fowler that the 25 per cent clause on the allotment of \$25,000 Federal aid to Coleman county on Highway No. 7-A be removed. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Avery that \$25,000 State aid be granted Smith county on Highway No. 37 north of Tyler, making a total of \$325,000 State and Federal aid granted this county. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Avery that Ellis county be granted \$58,102.67 State aid on State Highway No. 14 from Ennis south to the Navarro county line, Federal aid project No. 179, Job 71-A. Motion carried.

Motion by Mr. Avery, seconded by Mr. Fowler that Bowie county be granted \$3,000 additional State aid on Federal aid project No. 101, Highway No. 5 and No. 1-A, making a total of \$8,000 State aid to this project. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Avery that Ector county be granted \$2,007.56 additional State aid on State Highway No. 1 from Judkins to the Crane county line, which aid is to be fifty per cent of the following items, making a total of \$66,208.60: \$1,623.51 due on engineering; \$270.06 due on royalty on gravel; \$118.65 for clearing caleche pits; \$2,002.91 for removing unloading spur on the Texas & Pacific Railroad. Motion carried.

Motion by Mr. Avery, seconded by Mr. Fowler that Bee county be granted \$25,000 State aid on State Highway No. 9, Federal aid project No. 151. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Avery that Bexar county be granted \$25,000 Federal aid on State Highway No. 9, the Pleasanton Road. Motion carried.

Motion by Mr. Avery, seconded by Mr. Fowler that the \$125,000 Federal aid granted Howard county on State Highway No. 1 be canceled. Motion carried.

Motion by Mr. Avery, seconded by Mr. Fowler that Howard county be granted \$73,102 Federal aid on State Highway No. 1. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Avery that Howard county be granted \$73,100 State aid on State Highway No. 1. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Avery that the \$117,000 Federal aid granted Midland county April 20, 1920 on State Highway No. 1 be canceled. Motion carried.

Motion by Mr. Avery, seconded by Mr. Fowler that Midland county be granted \$64,000 Federal aid and \$54,734 State aid on State Highway No. 1. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Avery that the balance of \$123,998.96 State aid allotted to Ector county be canceled. Motion carried.

Motion by Mr. Avery, seconded by Mr. Fowler that Ector county be granted \$106,632 Federal aid on State Highway No. 1 from Midland county line to Judkins. Motion carried.



Motion by Mr. Fowler, seconded by Mr. Avery that Bowie county be granted \$1000.00 State aid on Hooks section of Federal aid project No. 101 on State Highway No. 5. Motion carried.

Motion by Mr. Avery, seconded by Mr. Fowler that Medina county be granted \$25,000 additional Federal aid on State Highway No. 2, making a total of \$60,000 Federal aid. Motion carried.

Motion by Mr. Fowler, seconded by Mr. Avery that Medina county be granted \$40,000 State aid on State Highway No. 2. Motion carried.
