WHEREAS, in SAN PATRICIO COUNTY on a new location from State Highway 361 approximately 0.9 mile east of its junction with Farm to Market Road 1069 south 2.2 miles to the junction of the proposed State Highway, a distance of approximately 2.2 miles, a State Highway is required because development of the Corpus Christi Homeport is expected to significantly increase the traffic on the highway system leading to the Homeport site;

NOW, THEREFORE, IT IS ORDERED that the Engineer-Director is directed to tender the following proposal to the City of Ingleside and San Patricio County:

Provided the City of Ingleside and San Patricio County will:

1. Provide ten percent of the cost of right of way clear of obstructions and free of cost to the State with acquisition procedures to be in accordance with policies of the State Department of Highways and Public Transportation and with applicable Federal and State laws governing the acquisition policies for acquiring real property.
2. Provide ten percent of the cost of utility adjustments as may be required in accordance with policies of the State Department of Highways and Public Transportation.
3. Provide for the cost of construction of continuous curb and gutter, storm sewers, driveways and sidewalks, etc. in accordance with applicable governing policies and regulations of the State Department of Highways and Public Transportation.

4. Upon completion of the construction of this project, maintain that portion of the work which is its responsibility in accordance with federal and state requirements, and agree to regulate traffic and prevent encroachment on the right of way, all in accordance with governing policies and regulations of the State Department of Highways and Public Transportation.

The State Department of Highways and Public Transportation will:

1. Provide ninety percent of the cost of right of way clear of obstructions with acquisition procedures to be in accordance with State Department of Highways and Public Transportation policies and with Federal and State laws governing the acquisition policies for acquiring real property.
2. Provide ninety percent of the cost of utility adjustments as may be required in accordance with policies of the State Department of Highways and Public Transportation.
3. Provide relocation assistance as may be determined to be eligible under the Relocation Assistance Program.
4. Provide for construction.
5. Maintain that portion of the work which is its responsibility in accordance with present maintenance agreements.

Upon acceptance of the provisions of this Minute Order by the City of Ingleside and San Patricio County, IT IS FURTHER ORDERED that a STATE HIGHWAY be and is hereby designated; and the Engineer-Director is authorized to proceed in the most feasible and economical manner with project development to include any necessary agreements, right of way acquisition, utility adjustments, relocation assistance and construction at an estimated cost of \$5,437,000.

This Order shall become operative upon acceptance by the City of Ingleside and San Patricio County; and if not accepted within 90 days of the date hereof, the action herein contained shall be automatically canceled.

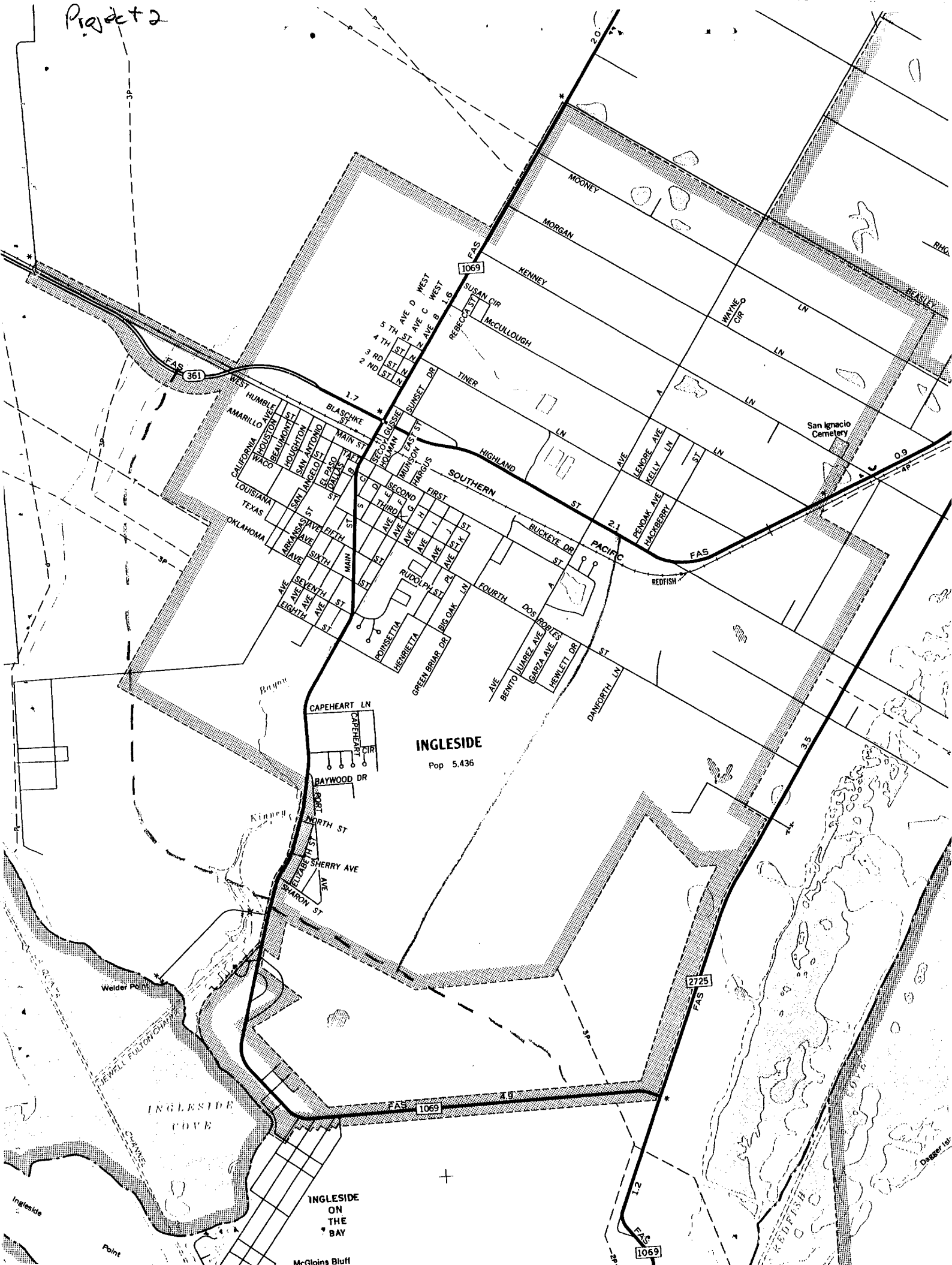
